A Brief on the Different Milestones for the Setting up of the MQA from 1997 to 2002 by Mr Roland Dubois,

Director of Mauritius Institute of Training and Development (MITD)



Following the attendance of the Director of the ex-IVTB in 1997 at a British Council sponsored workshop and a visit at the then SCOTVEC, in Scotland,

Maida Grant of the SCOTVEC was invited to Mauritius to run a workshop on the various aspects of a Qualifications Framework which was attended by both staff of the ex-IVTB and its partners in training from the private sector.

This workshop generated lots of interest. A paper entitled "A National Qualifications Framework for Mauritius" was subsequently presented by the Director of the ex-IVTB at International Quality the Congress organised in December 1997 by the MEF and the ILO. The then IVTB Council decided to initiate action for the setting up of a National Qualifications Framework in January 1998 after having analysed the inherent problems of the prevailing Education and Training system and identified the need for a National Qualifications Framework.

In order to take matters forward, support from the Scottish Qualifications Authority (SQA) (this had replaced the SCOTVEC in the meantime), to investigate into and propose a design for the implementation of a National Qualifications Framework in Mauritius was sought.

The deliverables were:-

- A detailed analysis of factors influencing implementation together with recommendations on how they should be incorporated within the implementation process;
- A model for a National Qualification Framework (NQF); and
- A plan for implementing the framework.

The SQA submitted their final report on the 23rd December 1998 and was considered by the IVTB Council in January 1999. But as the implementation of the recommendations necessitated a change in legislation, the report was submitted to the then Ministry of Education and Scientific Research and the Ministry of Environment, Human Resource Development and Employment for necessary action.

However, no major developments took place regarding the implementation of the recommendations. In October 2000, Government decided to look into the whole issue with a view to establishing an NQF. Consequently, Government set up a Project Steering Committee to study the SQA Report and the recommendations therein and make proposals for establishing an NQF in Mauritius.

The Steering Committee started its first meeting on the 12th January 2001. The committee was provided with feedbacks received on the SQA's proposals from various stakeholders. Furthermore, a delegation led by the then Minister of Skills Training, Development and Productivity and comprising the Chairman of the Steering Committee and the Director of the IVTB went on a study tour in Australia and New Zealand to look at the operation of the qualifications system in the two countries. Experience obtained during the study tour and relevant documentation brought back were fed into the work of the Committee.

The Project Steering Committee proposed a Mauritian National Qualifications Framework comprising 10 levels covering qualifications obtained from the primary school, that is, the CPE to the highest one obtained at a University, that is, Doctorate (Ph.D.), including qualifications obtained at the secondary schools, the TVET sector and workplace and the Tertiary Education sector, together with the definition of the different levels in terms of complexities of skills and knowledge, learning demand and responsibilities.

It has to be emphasised that training in Recognition of Prior Learning was also organised for some twenty participants coming from both the ex-IVTB and the private sector by a resource person from Australia.

The Steering Committee also recommended that the administration of the NQF be assigned to the Mauritius Qualifications Authority, the setting up of which had already been agreed upon.

The Steering Committee submitted its final report in September 2001 together with the first draft bill leading to the MQA Act that was given its assent in December 2001 by the President of the Republic of Mauritius thereby setting the scene for the setting up of the Mauritius Qualifications Authority which started its operation in May 2002.

In order to facilitate the MQA's initial operation, staff of the ex-IVTB working mostly in the Quality Assurance Division of the IVTB were transferred to the MQA and they have been the backbone of the MQA as an organisation.

Evolution of the MQA since its Inception

Setting Up of the MQA

The Mauritius Qualifications Authority (MQA) became operational since 08 May 2002 as a regulatory body for the training sector in Mauritius. The Authority took on lease 272 m² of furnished office space on the ground and first floors at the then IVTB House (now MITD House) where the officers were temporarily accommodated. The Chairman, Dr S Soyjaudah was designated Officer-in-Charge with effect from 26 March 2002 pending the appointment of the Director. The then Director, Mr P V Lutchmun subsequently joined the MQA on 28 January 2003 and the Deputy Director & Registrar, Mr R Phoolchund was appointed as from 01 April 2003.

On 08 May 2003, eight officers from the then IVTB were permanently transferred to MQA after a period of one year on secondment at the MQA.

Criteria for Registration & Accreditation

After the establishment of the Authority as a regulator for the training sector in Mauritius, policies were formulated in respect of criteria for the registration of Training Institutions, Trainers, Programme Officers and Managers; criteria for approval of courses; guidelines for the accreditation of training institutions. Application forms were developed for the following:

- Registration / Renewal of Training Institutions
- Registration of Trainers
- Registration of Programme Officers
- Registration of Managers
- Accreditation of Training Institutions
- Approval of courses

Meeting with Stakeholders

In October 2002, a meeting with stakeholders was held where the following

issues were discussed: (1) National Qualifications Framework (2) Accreditation Procedures (3) Registration Procedures.

Residential Seminar

A Residential Seminar was held from 20 to 22 June 2003 at Indian Resorts Hotel at Le Morne on the following themes: National Qualifications Framework and Level Descriptors; Standards Setting; and Qualifications & Related Issues. The seminar was conducted with the help of foreign experts namely Mrs Savita Kapoor, Independent Consultant from United Kingdom, Mr Brent Richardson of Cue F Consulting Ltd, New Zealand and Mr Joe Samuels of South African Qualifications Authority, South Africa.

MQA Logo



The MQA logo was officially presented to the public at the Residential Seminar on 20 June 2003 and same is being used in all correspondences of the MQA.

MQA New Premises

The MQA moved to new premises in November 2003 after having taken on

lease a building from the then IVTB (now

MITD). The occupation of the building was preceded by an inter-religious ceremony on 23 October 2003.

Workshop on Standards Setting and Qualifications

The MQA hosted a workshop on Standards Setting and Qualifications, held from 13-18 September 2003 at Gold Crest Hotel, Quatre-Bornes. This workshop conducted by Mr Brent Richardson from New Zealand, Consultant and Director of Cue F Consulting Ltd. Five major issues were dealt with during this workshop namely (1) Qualifications Framework (2) Standards Setting (3) Qualifications Recognition of Prior (5) Implementation Issues. A public lecture on Standards Setting and Qualifications was also held on 17 September 2003.

Around 125 participants comprising key stakeholders and members of the public attended the lecture.

The National Qualifications Framework (NQF)

The NQF consists of 10 levels of hierarchy, starting with Certificate of Primary Education (CPE) at Level 1 up to Doctorate at Level 10. The levels are defined by descriptors which are broad descriptions of learning outcomes at a given level of knowledge, skill and competence. The NQF provides a clear pathway for learners to pursue further education/training and life-long learning.

Industry Training Advisory Committees (ITACs)

The ITACs set up by the MQA comprise members of the public and private sectors and their role is to generate Unit Standards and Qualifications and create links between Industry and the MQA. In 2003-2004, Unit Standards in the following sectors had been developed: Information and Communications Technology, Tourism and Hospitality Management and Printing.

MQA Website

The website www.mqa.mu of the MQA was launched on 21 October 2003 and was hosted at the National Computer Board (NCB). The website provided a spectrum of information ranging from registration aspects to contact details. Application forms could be downloaded in word and pdf formats. The website is an important interface with the public.

Workshop on Recognition /Accreditation of Prior Learning (RPL/APL)

A workshop was held by the MQA on Recognition/Accreditation of Prior Learning (RPL/APL) from 10-14 November 2003. The workshop was conducted by Dr Amina Barkatoolah, Consultant of ABC Consulting. Staff of the MQA and various stakeholders participated in the workshop. A public lecture was also held on 13 November 2003 at the then IVTB House, where Dr Barkatoolah emphasised that the RPL/APL concept would help employees to formally obtain accreditation for knowledge, competences, and other skills they might have learned and acquired. Over 100 participants comprising stakeholders and members of the public attended this lecture.

Study Tour of Delegation from Seychelles

A delegation from the Ministry of Education of the Seychelles, comprising the following officers: Jean Michel Domingue - Director of Higher Education Development, Marie Thérèse Purvis - Director, National Institute of Education and John L'Espérance - Coordinator, Technical and Vocational Education and Training was on a study tour in Mauritius from 24-28 November 2003. The aim of this visit was to set up a proper Qualifications Framework so as to dispense post-secondary technical education in the Seychelles. The delegation had working

sessions with the Chairman, Director and Staff of the MQA whereby the following issues were discussed: Setting up of the NQF; Registration Procedures for Training Institutions, Managers, Programme Officers and Trainers; Standards Setting; and Recognition/Accreditation of Prior Learning (RPL/APL).

ZOPP - A Tool to Strategise

The MQA organised a ZOPP Workshop on 13 and 14 August 2004 at Domaine Les Pailles whereby MQA Board Members, staff and various stakeholders were brought together in a process of collective thinking. Mr N Treebhoohun, the then Executive Director of the NPCC acted as the facilitator for this brainstorming session. The MQA have "valued vision of to qualifications for employability and lifelong learning" and the mission "to continuously enhance good practices and relevant expertise to safeguard public interest in quality education and training" had been developed during this ZOPP exercise and the core problems were identified.

Workshop on Unit Standard and Qualifications in ICT & Printing


The MQA hosted a four day workshop from 23 to 26 August 2004 at the then IVTB House, Phoenix. This workshop allowed the training of the MQA staff and various stakeholders in the generation and development of Unit Standards and

Qualifications. The Resource Persons for this workshop were Mr Keith Weller from Qualifications and Curriculum Authority (QCA), UK and Dr (Mrs) Amina Barkatoolah from France. The workshop was followed by a half-day seminar held on 27 August 2004 at the then IVTB Lecture Theatre, IVTB House, Phoenix with a view to sensitising stakeholders on the implementation of Unit Standards and National Qualifications in Information the sectors Ωf and Communication Technology (ICT) and Printing.

Seminar on Unit Standards and Qualifications in Tourism & Hospitality Sector

The MQA organised a Seminar on Unit Standards and National Qualifications for the Tourism & Hospitality Sector at the Hotel School of Mauritius on 08 November 2004. The objective of the Seminar was to sensitise the MQA's stakeholders on the implementation of Unit Standards and National Qualifications in the Tourism & Hospitality Sector. Emphasis was laid on the importance of having the outcome-based qualifications which could help to reconcile job titles with competences in the hotel industry. The outcome-based qualifications would be a reference for training providers to develop their own programme, which would consist both of theory and practical modules. The assessment would essentially be based on the performance criteria and successful achievement by trainees and subsequently, qualification awarded by a recognised Awarding Body.

MQA Directory 2004-2005



The first issue of the MQA Directory 2004-2005 had been published. The MQA Directory was designed to help the general public & prospective learners to make an informed choice in training & Education. This Directory had been made available for consultation at the MQA and on MQA's website.

Resignation of Director & Appointment of Officer-in-Charge

Following the resignation of the then Director, Mr V P Lutchmun on 18 May 2005, the Deputy Director & Registrar, Mr R K Phoolchund was appointed as Officer-in-Charge of MQA with effect from that date until 31 August 2006.

Proclamation of The Education and Training (Miscellaneous Provisions) Act 2005

Following the coming into operation of The Education and Training (Miscellaneous Provisions) Act in July 2005, the MQA had been attributed the responsibility to regulate the training sector with focus on Technical and Vocational Training and to inter-alia register Qualifications other than those obtained in the Primary, Secondary and Post-Secondary Educational sectors. In order to give effect to the implementation of the provisions of The Education and Training (Miscellaneous Provisions) Act, a handing over exercise was carried out since early July 2005 with TEC in respect of applications received at the MQA from training institutions for accreditation regarding courses considered to be fulfilling Post-Secondary Education requirements.


Policy on Recognition and Equivalence of Qualifications

As a result of the promulgation of The Education and Training (Miscellaneous Provisions) Act 2005, the National

Accreditation and Equivalence Council (NAEC) had been dissolved and its function in respect of recognition and evaluation of qualifications, other than those obtained in the Primary, Secondary and Post-Secondary Educational sectors, for the purpose of establishing their equivalence, had been transferred to the MQA. A policy was thus formulated following the constitution of a Recognition and Equivalence Committee which initially comprised members mainly from the MQA and also a person from the Ex-NAEC. The policy had been inspired by the requirements to the access of the world of work and by the philosophy of lifelong learning. It is based on the Lisbon Convention on the recognition qualifications (Lisbon 11.IV.1997) and on principles stipulated in the UNESCO/Council of Europe Code of Practice in the provision of transnational education. The policy has also been benchmarked against best practices available in European countries as well as in South Africa and New Zealand.

Customer Charter

With a view to providing a better service to customers, a Customer Charter was adopted at the MQA on 17 June 2006 on the basis of the following 11 principles:

Appointment of New Director of MOA

A new Director was appointed for the MQA in the person of Mr Kaylash Allgoo and he took office with effect from 01 September 2006.

New Industry Training Advisory Committees (ITACs) in 2006-2007

New ITACs have been set up in 2006-2007 in the sectors of Textile & Apparel, Health & Social Care, Adult Literacy, Jewellery and Building Construction & Civil Engineering to generate Unit Standards and Qualifications at various levels of the NQF at the Technical and Vocational level.

IC3 Programme

The MQA approved during 2006-2007 the dispensation of the Internet and Computing Core Certification (IC3) training programme for delivery at national level. With a view to promoting lifelong learning and expanding the qualified labour force in Mauritius, learners having followed the IC3 programme will be granted exemption for some modules of the National Certificate in Computing

Level 2. Subsequently, the learners could climb the ladder of the NQF.

The workshop was held with a view to adopting the principles of good Corporate Governance in order to ensure better performance and organisational effectiveness at the Authority.



The SQA is the national body in Scotland responsible for the development, accreditation. assessment and certification of qualifications other than degrees. Ms McKerracher has a wealth of knowledge in relation to qualification frameworks. credit levelling and qualifications development.

Management Information Systems

After the MQA came into operation, all the tasks and records were being carried out and kept manually thus making sorting

and searching of information as well as retrieval of specific details very difficult. With time the need to have an Integrated Management Information System was increasingly being felt so as to allow the MQA to manage more efficiently and effectively all its functionalities. On 30 April 2007, the contract of computerising the MQA business processes was awarded to Harel Mallac Technologies Ltd. Since then, Harel Mallac Technologies Ltd. has with the continuous support of MQA staff installed various systems which aimed at offering all the informative, interactive, transactional and collaborative services for the activities of the MOA



These systems also provide the tools that will help work in a smarter manner, while supporting the effective and efficient use of the resources employed, ranging from time to energy. At the heart of the objectives to be met by this project, 'Customer Service' has been given its right place. The new Information System has all the pre-requisite components generally employed in providing information support to Management to make planning and control decisions.

Workshop on Recognition of Prior Learning on 17-18 May 2007

In line with the Government policy to make Mauritius become a knowledge hub, the MQA had already initiated actions for the implementation of the Recognition of Prior Learning (RPL) so as to contribute towards the development of an efficient and vibrant human capital to sustain economic development. In this regard, technical assistance was also being sought from international institutions for the smooth realisation of this project. With a view to further sensitising our immediate stakeholders on the concept of RPL and on the complexities involved in the implementation of this project, the MQA in collaboration with the Commonwealth of Learning (COL) organised on 17 and 18 of May 2007 a two-day workshop at La Cannelle, Domaine Les Pailles.

Regional Activities

The MQA had also been strengthening its international as well as regional linkages with overseas Qualifications Authorities. This not only gave MQA access to possibilities of collaboration in various fields but it also led to sharing of expertise and knowledge and to ensure comparability of education and training standards in line with the SADC Protocol to bring about harmonization of qualifications across the SADC region.

It was in this context that MQA signed in 2007 a Memorandum of Technical Cooperation and Partnership with the Namibia Qualifications Authority (NQA) as well as with the Botswana Training Authority (BOTA).

New Quality Assurance Standards

The training sector had been evolving significantly over the years since the start of operation of the MQA with the emergence of new forms of learning and training practices. It had therefore been essential that training requirements and standards of practice be reviewed and amended as per international norms and best practices. It was in this context that a new set of training standards had been developed to become applicable with effect from July 2007.



Interview with Ms Anjali Peeroo, Executive Officer at the MQA

1) Ms Peeroo, when did you join the MQA and what is your position in the Organisation?

Well first of all, let me thank the Editorial Team for this opportunity and I feel honoured and privileged to contribute in the context of this publication.

I joined the MQA 'on secondment' from the IVTB (now MITD) on May 2002 and I worked as Clerk/Word Processing Operator. In fact I am one among the 9 first officers who joined the MQA when it was created.

In 2005, I was promoted to the post of Executive Officer and since then I am occupying this post in the Corporate Services Division of the MQA.

In short, I may say that I am one of the pioneers at the MQA and I have witnessed the gradual growth of the Authority throughout its 10 years of existence.

2) Given you are here since the inception of the MQA, please tell us briefly what has been the major achievements of MQA?

The Authority has been able to implement the certification of competencies especially when these competencies are obtained outside the formal Education and Training System. Similar to the NQF, RPL has equally been

an another turning point in the growth and achievement of the MQA.

In a short span of 10 years, I may say that the hard work and contribution of one and all, has led the MQA to expand and grow at national as well as international level.

3) Ms Peeroo, are you happy with the working environment that prevails at the MQA?

In very simple terms, I can say that I am very happy to be at the MQA and a good working environment prevails in the organization. The working relations among the departments and between members of the staff are excellent.

So far, I myself have not witnessed any conflicts within the organization and the staff are happy in their jobs. I see management very concerned with staff development and growth and they pay good attention to any staff requests and queries.

Moreover, at the MQA, we have an established recognized Staff Welfare Association for years now and this Association is very active in its objectives and is always doing its best for the welfare of the MQA staff.

4) Any comments on the way the Authority is being governed?

Well, the MQA is being governed by the MQA Board and it is known to one and all that the road to success for the MQA has been the decisions of our Board Members and Chairpersons.

The entrusted responsibilities have been fully accomplished by our visionary leaders who in fact have taken the right policy decisions at the right time.

5) The way forward that you Ms Peeroo would personally wish for the MQA.

The evolution of life is that of growth and expansion, likewise, for the MQA I would wish that after 10 years now, the journey continues and there be no end. 


